Trash Collection

Residents are reminded that there is a two (2) bag limit per household. Trash and recycling are not to be placed out for collection earlier than 6:00 p.m. the evening before scheduled collection date. Collections will occur on Thursday.

Bulk Item Collection

One (1) bulk item collected once a month. Bulk items will be collected on the first (1st) Thursday of every month along with normal collection. Serviced by J.P. Mascaro & Sons. One (1) bulk item (i.e. mattresses - must be wrapped in plastic. furniture, etc.) per household is permitted per week. No tires, TVs or computers. Call J.P. Mascaro & Sons at 1-800-334-3403 for "white" item pickup (i.e. washing machine, dryer, etc.). For White items containing Freon (i.e. refrigerators, air conditioners or window units) remove freon and certify with a sticker before placing item curbside.

E-Waste Alert! Disposal Ban

Solid waste disposal facilities in Pennsylvania are no longer allowed to accept covered devices such as televi-

sions and computer devices including hard drives, monitors, keyboards, mice and printers or their components.

Household Hazardous Wastes Not Accepted!

Toxic chemicals, pesticides, oil-based paints, weed killers, automotive batteries, fuels, or fluids must be disposed of properly. Refer to the Chester Solid Waste Authority's website (www.chestercountyswa.org) for options.
